### **Making a Difference**

Our charity, the **Bright Horizons Foundation for Children**, creates Bright Spaces –

special play environments for traumatised children. Many of you generously support the Foundation and here are some examples of how your donations make a difference:

## How your donations make a difference:



- £12 = books for children using a Bright Space
- £60 = a baby gym and mat for a baby living in a refuge
- £360 = a Teen Bright Space in a police station for child abuse victims
- £720 = a mobile Bright Space for a domestic violence outreach worker
- £6,000 = creates a complete Bright Space in a homeless shelter or refuge



## Making a Difference with Your Employer

Does your employer **make charitable donations on your behalf** or offer **match-funding** for charitable donations you make? These are great ways to boost the value of your donations and, more importantly, enable us to **impact more children and families** experiencing crisis and disadvantage.

If your employer has a **payroll giving scheme**, such as **CAF Give As You Earn**, you can give directly to charity from your pay – before tax is deducted. This means you get tax relief, depending on the rate of tax you pay. For example, if you're a basic rate taxpayer, giving £1 would only cost you 80p.
